Visitation Status:

Visitors are allowed: We have increased our visitation to include both indoor (room) visitation for residents with private rooms, indoor designated area for residents in a semi-private room and outdoor visitation.

Visitation will be scheduled within the facility's established days and times (Monday - Friday 10:00am – 7:00pm and Saturday - Sunday 9:00am thru 12:00pm. Lunch break is from 12:30 – 1:30pm daily). If these times do not fit your schedule please reach out to us for other opportunities. We highly encourage you to schedule your visits so we can accommodate you without you having to wait by calling Krystal Simonds the receptionist at 240-448-2000, Monday through Friday between the hours of 8:30am and 4:30pm.

Visits start at the top of the hour and last 30 minutes. No more than 2 visitors at each visit. If more than 2 people would like to visit a time, we suggest requesting an outdoor visit to accommodate the visitation. If you are unable to visit in person, the Activities Department is still scheduling the face time/ virtual visits via phone or hand held tablets.

For vaccinated residents and visitors: when visits are in the resident's private room (no roommate) or designated visitation area, residents and visitors may choose to have close contact including touch and do not need to wear source control (mask). The visitor must still pass a screening upon entry and wear a mask to and from the designated area of visitation. The visitor should socially distance from healthcare personnel and other residents and visitors.

When neither the resident or visitor is not vaccinated: the safest approach for everyone is an outdoor visit, social distancing and source control (mask). However, if the resident is fully vaccinated and they choose to have close contact (including touch) with their visitor (s), both must wear a well-fitted source control (mask). The visitor (s), both must wear well-fitting source control (mask). The visitor still need to pass a screen upon arrival and wear a mask to and from the designated visiting area.

Facility Safety Precautions:
